How does a writer use elements of fictions to develop a theme?

Directions:

Over the course of the this unit, we have studied Harper Lee's *To Kill a Mockingbird* and viewed Kathryn Stockett's *The Help*. Both works explore the idea of injustice in the segregated South, one in the 1930s in Alabama and one in the 1960s in Mississippi. They also explore the idea of how one person can initiate change within society. Other theme topics explored in the works include the following: isolation, appearance vs. reality, prejudice, loss of innocence, levels of society, and courage.

For this essay, please choose a common thematic message and then analyze how each author uses two elements of fiction (characterization, point-of-view, setting, diction, conflict, motif, or symbol) to support and build this message.

Thematic message examples)

Isolation can be destructive.

People need to have connections with other people in order to be happy.

Those at the lower levels of society have the least power and influence over that society.

Those at the top levels of society have the most power and influence over that society.

One person has the power to change an unjust society.

A person can never be judged merely by his or her appearance.

Part of growing up involves learning about the ugly parts of society and people.

Despite their lack of equality, women have more power than men in these societies.

A person's race determines the amount of power he or she has in society.

Social class determines a person's identity and place in society.

One courageous act can initiate change in society.

The level of prejudice a person has toward another group depends not only upon the society in

which he or she lives but also upon his or her experiences growing up.

Prompt Broken into Steps: 1) Identify Common Thematic Topic between the two works. 2) Create theme statement from the common thematic topic. 3) Choose two elements of fiction (characterization, point-of-view, setting, diction, conflict, motif, or symbol). 4) Analyze how each work uses each of the chosen elements of fiction to create the corresponding thematic message.
